## The City of Ohrid as a UNESCO World Cultural Heritage Site: Challenges and Solutions for Cultural Tourism Development

Sasho Korunovski and Michael Risteski

#### Abstract

The City of Ohrid represents an important site with UNESCO status of mixed heritage located on the historic route of Via Egnatia. It is the most important tourist center in the Republic of North Macedonia and therefore faces numerous development challenges. Namely, urban and tourism development has caused several risks and dangers to its protection status in the past which is also prevalent to the present day. Since its proclamation as a World Cultural Heritage Site the city of Ohrid and its surroundings had constantly been trying to find a balance between the increase in tourist visits on one side, and the protection of its cultural and natural values, on the other. This paper will explore the developmental path of this area with its different socio-economic and environmental challenges and impacts in its pursuit to achieve long-term sustainability. In that sense, several strategic documents will be analyzed in which the most recent protection measures and activities have been envisioned to be implemented in the near future. This will also include sustainable solutions and recommendations for improvements mainly in a tourist-developmental and preservation sense. This is important for the city to transform itself into a sustainable, yet highly competitive global tourist destination.

#### 1 Introduction

World Heritage Sites (WHS) represent an important potential for tourism development of many regions/countries in the world. The designation "UNESCO World Heritage Site" is an important promotional tool for the development of tourism. Many destinations have built their tourist brand around these designations. Such a site is the city of Ohrid in the Republic of North Macedonia. The city with its surroundings has been proclaimed a World Cultural and Natural Site since 1979 and 1980 (Mixed Heritage Status). The Convention concerning the Protection of the World's Cultural and Natural Heritage was adopted by the United Nations Educational, Scientific and Cultural Organization (UNESCO) in 1976 with the purpose of "identification, protection, conservation, presentation and transmission to future generations of cultural and natural heritage of outstanding universal value" (Leask and Fyall 2006). Sites are being designated through a set of determined criteria which must be followed. The designation process is being conducted through the system of inscription of the site in the World Heritage List (WHL). This includes adopting a set of operational guidelines and periodic reporting processes. The state of conservation of World Heritage properties is being conducted by the World Heritage Committee through monitoring processes which can be either periodic or reactive (UNESCO World Heritage Centre 2012). The Ohrid region has been inscribed in the World Heritage List since 1979 (Decision No. 03COM XII.46), for its natural values according to the selection criterion (viii): "to be outstanding examples representing major stages of earth's history, including the record of life, significant on-going geological processes in the development of landforms, or significant geomorphic or physiographic features" (UNESCO World Heritage Committee 1979). This inscription has been widened in the following year on its cultural values (Decision No. 04COM V.13), according to the following selection criteria: (i): "to represent a masterpiece of human creative

the Ohrid region will create increased costs for the government's undertakings for solving the current problems and threats (such as increased spending for conservation activities, conducting visitor impact studies, decreasing/regulating the number of visitors in some of the cultural sites, etc.). In the long run, such higher government spending should ensure an increase in the quality of the tourism offer and higher competitiveness of the destination through developing sustainable tourist activities, redirecting tourism flows and active involvement of the local population in creating alternative tourist offers. Therefore, the practical benefits of this research are evident in the economic, social and cultural spheres. Furthermore, this paper's practical implication stems from the fact that the findings are incorporated in the newly adopted tourism strategy of the municipality of Ohrid. More precisely, it provides clear directions for cultural tourism development in the municipality that is based on the principles of sustainability. The findings provide proposals for alleviating some of the pressures on the cultural values and attractions in Ohrid, but also solutions for redirecting the current tourism flows towards different cultural localities and resources located outside the city core and within the boundaries of the municipality of Ohrid. These proposals and solutions have practical significance because they will be implemented through a detailed Action Plan within the adopted strategy. This in turn will lead the region of Ohrid to become a recognizable and sustainable tourism destination of global significance by maintaining its WHS status.
